Wisper Telecommunications, Inc. (WisperTel) maintains this Web site as a service to its customers. By using web sites owned and operated by WisperTel or its affiliates, you are agreeing to comply with and be bound by the following terms of use, which may change at any time.

WisperTel is committed to honoring the privacy of it's members and visitors.

What information does WisperTel ask for and how is it used?

When you register for any of WisperTel services, you will be asked to provide certain information, such as your name, contact information (including valid e-mail addresses), billing/payment information. Some of the services provided by WisperTel, such as WisperTel Web Hosting, may have additional terms of use that you should read to better understand all of your options regarding your personal information. Personal information (nonpublic information) will not be released to anyone unless we are compelled to do so by law. Personal information will not be released to any third party without providing you a disclosure notice with an "opt out" choice. Personal information will only be shared under the following conditions both during and after you are a WisperTel subscriber: 1. when a subscriber requests or gives permission to do so, 2. when required or permitted by federal, state, or local law or regulation, 3. when fraud or dishonesty is suspected, 4. when we retain legal counsel or a collection agency to collect on an overdue account.

WisperTEL respects the privacy of its customers and does not sell any personal data or contact information to any third party. Every WisperTEL customer is automatically included in WisperTEL mailings, e-mailings and other company communications. Each WisperTEL customer has the option to exclude themselves from select company communications, if they so desire.

Do I get to choose what information I disclose while using the Internet?

Yes, you can always choose whether or not to disclose information to WisperTel. Certain information is required for registration, but other requested information is optional and may be given at your discretion. Some WisperTel services may require that you provide personally identifiable information. We may use "cookies" to let you use our services more easily, and to let us keep track of certain statistical information that helps us improve our site. Who has access to my personally identifiable information?

We require certain specific information when you subscribe to some customized services or purchase products, and we store that information in secure databases. We may, at our discretion, share information, both personally identifiable and aggregate data, with companies who provide content to portions of our site and communicate with you on behalf of WisperTel. They are given limited access to our secure database, and will receive information only if you visit their site via WisperTel and choose to sign up for one of the related services, purchase their products, or give your consent for information to be sent to you.

What if I need to change the personal information I previously disclosed?

We encourage WisperTel members to update and edit their personal information and keep it current. You can update your personal information by e-mail.
